Types of Planned Giving

Bequests:


You can arrange a **specific bequest** in your will or living trust of money, investment holdings, property or real estate. You can also leave a **residuary bequest**, designating a portion of your estate for the library after debts, expenses and specific bequests have been paid, so you can have peace of mind that your intentions will be fulfilled without the estate running out of assets to distribute.

Retirement Accounts:

If you have a retirement account you no longer need, you can make a direct transfer of funds from your IRA to a qualified charity like the ImagineIF Library Foundation. This can also satisfy your required minimum distributions for any given year.

Life Insurance:

You can leave a currently owned or new policy to the library by naming the ImagineIF Library Foundation as the primary beneficiary of your life insurance. This option also provides an estate tax deduction.

Endowment: A Gift That Keeps on Giving

In 2018, Barbara Guttschenritter, a devoted library supporter and board member, established the ImaginelF Library Endowment Fund. The Endowment Fund is an investment account that generates income for the library while retaining the fund principal.

If you designate a gift for the Endowment Fund, your contribution becomes a perpetual wellspring of support.
